Our Solution: The CLOUD Co-Operative

The Collective of Local Organizations Utilizing Democracy (CLOUD) is designed to meet the need of its members first by:

- Leading with equality, fairness, and democracy
- Providing local businesses with access to resources, bargaining power, and a better chance to reclaim space in Portland

Research & Feasibility

Small businesses account for **99% of Oregon's businesses** and employ 55% of the state's workers. By Oct. 2, 2020, the pandemic had resulted in the temporary closure of **170 small businesses** and permanently shuttered **20 businesses**.

In 2020, 83 restaurants closed, with 16 additional closures in 2021. Closures are mainly a byproduct of rental and leasing issues. Oregon's back rent is estimated to be between **\$249 million to \$378 million**. Office vacancy rates jumped from 10.6% at the beginning of 2020 to **13.6%** by the year's end.



Payment Mechanisms

The March 2021 **COVID-19 relief bill** provides a variety of **government funding** for alleviating the financial difficulties caused by the pandemic.

- * Targeted EIDL Advance
- Paycheck Protection Program
- Vaccination site funding

This funding will not last forever, and **the CLOUD** must grow to be **self-sustaining** on its own as its member businesses recover. Ultimately, **the CLOUD** will rely on **membership fees** and **revenue sharing** to cover its own costs and operate fully independent of government aid.

Cost/Benefit Analysis

Parameters: feasibility, initial & long-term gain, social gain, economic gain, sustainability, job creation Option 1: **The CLOUD**

- Higher initial investment, bigger potential gains, high barrier to entry
- Option 2: Pop-up shops
 - Faster implementation, no longevity, little sustainability
